Point to remember. The GC presents new initiatives, and we receive the report. Then our organizations work through it to apply it and adopt it to our needs.

GC Master Guide Curriculum status update

Nestor Osman presented the report. He is the project leader for the new curriculum.

- A new and simpler structure is intend to make it easier for a new candidate to follow.
- The four sections of this curriculum are based on Jesus' four development areas, mentioned in Luke 2:52 "And Jesus increased in wisdom and stature, and in favor with God and men." As well as mentioned by Mrs. White in *True Education*, page 13, "True education means more than pursuing a certain course of study. It has to do with the whole person, and with the whole period of existence possible to human beings. It is the harmonious development of the physical [stature], the mental [wisdom], and the spiritual [favor with God] powers. It prepares the student for the joy of service [favor with men] in this world and for the higher joy of wider service in the world to come."
- In the current (2013) Master Guide Curriculum, 80% of the requirements are mental/academic, 7% are physical, 7% are social, and 6% are spiritual.
- In the proposed Master Guide Curriculum (under late stage development), 39% of the requirements are mental/academic, 11% are physical, 21% are social, and 28% are spiritual.
- There is more clarity as to prerequisites.
- There is increased emphasis on physical and digital outreach.
- There is accommodation for special needs.
- There are a variety of evaluations, including discussions, one-page reports, videos, presentations, and social media.
- There is a special emphasis in turning pure mental requirements in spiritual requirements.
- There is a written statement on how to validate academic requirements for this curriculum.
- There is flexibility for variations between world divisions.

MGI #20.04 Addendum to the MG Club Manual

Can I still be a part of a Master Guide club after I become invested? "Yes, once a Master Guide becomes invested his/her role changes from being a trainee to becoming the trainer. The Master Guide can still be a part of a church Master Guide club and remain an active staff member of an Adventurer, Pathfinder club, serve in AY as well as serving as a mentor to a Master Guide candidate within their club."

Discussion:

AU — This statement indicates that to remain, you must remain part of the training team.

 $\mathrm{CU}-$ "and remain" should be "must remain"

MAU — This seems to contradict the MG definition we just voted. *Response:* Much discussion.

NPUC —"serve in AY" should be "serve youth"

PUC — We are still not clear on what happens when an invested MG joins a MG club. *Response:* This statement says they must be involved with training in the MG club and/or with Pathfinders or Adventurers.

SDACC -- "The trainer" should be "a trainer"

Unions not listed had no comment.

Revised text as voted:

"Once a Master Guide becomes invested his/her role changes from being a trainee to becoming a trainer. The Master Guide can still be a part of a church Master Guide club and must remain an active staff member of an Adventurer, Pathfinder club, serve youth as well as serving as a mentor to a Master Guide candidate within their club."

MGI #20.05 Master Guide Club

Unions reported on their current concerns with the MG Club program:

AU — Commends the MG FG for the work they have done. We stand in total support. We have two concerns: Many would prefer "MG Candidate Club" as a name rather than "Master Guide Club." Second, is there any statement in the document giving authority to the Conf. Youth Department to say no. *Response:* You have the same authority as you have with Pathfinders and Adventurers. (From the MG Club Manual, Page 16: Counsel with the Conference Youth Director. The Conference Youth/MG Director is responsible for all Master Guide Clubs in the Conference. Any person in a local church who sees the need for a MGC has to consult with their Conference Youth/MG Director before making further plans.) **SDACIC** — We support. As to MG Candidate Club club, just as you become a Pathfinder when you join the club, you become a member.

SU - Gulf States spoke: Two years in the works. Our conference is very excited by this.

SWU — We also have a question on the name of the club.

Unions not listed had no comment.

MGI #20.09 A brief history of MG and our future

Dixie Plata shared some history. First Master Comrade investitures were in 1922 and 1923. If you were a conference President or Secretary you became a Master Comrade. In 1950 the name was changed to avoid political issues. The purpose of the program was to train church members. The MV uniform of the 1930's become the Pathfinder uniform.

Each Union was asked to compile a list of things that need to be changed or need to be reconsidered about Master Guide Ministry in NAD. Unions submitted handwritten lists.

- 1. We need to be more intentional in getting new Master Guides involved immediately.
 - a. At investiture, assign a mentor who will work with them to help them take on leadership in the first year.
 - b. Have something for them to do as they come off the stage from investiture.
- 2. More resources for the retention of Master Guides in ministry.
- 3. Fix the current curriculum. Lay people just being nominated look at the requirements and say it is impossible with full time jobs, family, and active participation on local club ministry. It is overwhelming. This should be leadership training, so focus on equipping them to be leaders. Make sure every requirement is essential to equip them for leadership.
