

Provide appropriate adult supervision at all times for the children for whom I am responsible.

 Children must be under adult supervision at all times.

DNT...

Have at least one other adult, eighteen (18) years of age or older, to help with the supervision of children. If I find myself in a situation where I am the only adult present, under no circumstances will I allow myself to be alone with one child (the "two-person rule"). This protects the child as well as protecting the adult from possible allegations.

2. It is important that volunteers and leaders follow the "two-person rule"

MY COMMITMENT TO VOLUNTEER MINISTRY AS A YOUTH/CHILDREN'S MINISTRY VOLUNTEER, I WILL:

Ask a child's permission before physically touching him/her anywhere, even when responding to an injury or problem. This is especially true for any areas that would normally be covered by a T-shirt and/or shorts. If an injury is within this area, make sure another adult works with you as care is

MY COMMITMENT TO VOLUNTEER MINISTRY AS A YOUTH/CHILDREN'S MINISTRY VOLUNTEER, I WILL:

Refrain from physical and verbal attacks and corporal punishment which are inappropriate behaviors and should never be used as discipline. "Time outs" or "sit-in-that-chair" may be helpful discipline methods to use with children.

CONT... MY COMMITMENT TO VOLUNTEER MINISTRY AS A YOUTH/CHILDREN'S MINISTRY VOLUNTEER. I WILL

5. Affirm children with appropriate touching by keeping hugs brief and "shoulder-to-shoulder" or "side-to- side." I will keep hands at (not below) the shoulder level. For small children who like to sit on laps, I will encourage them to sit next to me.

ONT... AY COMMITMENT TO VOLUNTEER MINISTRY AS A YOUTH/CHILDREN'S MINISTRY VOLUNTEER, I WILL:

- Provide extra care when taking small children to the restroom. I will take another adult along, or leave the door open.
- Be aware of conducting activities in rooms that do not have an interior viewing area, or I will leave the door open during the activity to allow easy observation by others.

It is imperative that leaders and volunteers do not take minors alone to the restroom. If there are only two adults with a group of children, take the whole group with you. This way you will have another adult with you to assist you. Do not allow teenagers, or another minor take children to the restroom unless they are from the same family.

d. "All volunteers referenced in this section include all adults, over the age of 18, involved in any capacity in children and youth ministries and

activities, and all church ministry leaders and officers voted or appointed by the local church consistent with the SDA Church Manual; volunteers voted or appointed by the conference, union, or the North American Division and its affiliates, as well as all registered volunteers either from within or outside the North American Division voted or appointed to serve in the territory."

2. Volunteer Selection and Management

a. Selection and Screening of Volunteers

vi. All volunteer

leaders, regardless of their previous experience, shall submit to the screening procedure provided by the church. The volunteer screening procedure should be updated for each individual every three (3) years.

Be aware of the signs and symptoms of child abuse and aware of the legal requirements for reporting suspected cases of abuse. In addition to any legally required reporting, I agree that if I become aware of any behavior by another individual which seems abusive or inappropriate towards children I am supervising, I will report that behavior to the church pastor, elder, or directly to the Conference Administration or Risk Management Director.
